We, Amadeus Group, want you to be familiar with how we collect, use and disclose Personal Information (information that identifies you as an individual).

Who is collecting and processing the Personal Information

This Amadeus Airline Marketing Automation Privacy Policy (the "Privacy Policy") applies to Personal Information that Amadeus IT Group SA may collect through this website (the "Site"). Information you give us

Information we and our third party service providers may collect from you

For what purpose is your Personal Information used?
